- Services include Know Your Rights presentations, a warm line for counsel and advice, and individualized support for clients with a higher level of needs



The Problem

In 2017, the Bronx had **more**than 30% of all child removals
for New York City



EARLY DEFENSE IN THE **FAMILY** DEFENSE PRACTICE

FDP Early Defense Team provides members of the Bronx Community with representation throughout investigations conducted by Child Protection Services ("CPS") with the aims of preventing Family Court involvement and reducing the harm imposed by the Family Regulation System

- Mandated reporters, by law, have to report any <u>suspected</u> neglect or abuse toward a child/children to the State Central Registry (SCR).
- This triggers a 60 day investigation against the parents or caretakers.
- Unlike a criminal case, there are no Miranda rights.

 Throughout the investigation you are not entitled to any legal representation.

OUR MODEL

What We Do

Help parents identify sources of support, like family members

Internal referrals for civil matters such as housing, immigration, and public benefits advocacy



Advise parents of their rights and responsibilities

Communicate with various individuals involved in the family's life, including CPS, schools, medical and service providers

Connect parents to evidence-based, family strengthening services for themselves and their children, as identified by the parent



Attend interviews, meetings, including the child safety conference


GETTING CPS REPORTS AMENDED AND SEALED

 In NY, once a 60-day CPS investigation has concluded, often times that investigation results in an "indicated report" of child maltreatment against the parent

An indicated report against a person can remain in the State's Central Registry for Child Maltreatment for many years and can have an adverse impact in employment, licensing, and in seeking to become an adoptive or foster parent

The FDP EDP Team assists clients in challenging these reports by providing advise and/or representation at fair hearings

OUR IMPACT



During the 3rd quarter (January 1, 2022-March 31, 2022) of Fiscal Year 2023, we served 320 clients of the Bronx community. Of those clients we served, we saw the following Early Defense Advocacy outcomes:

230 clients avoided Article 10 cases filed in Court. 40 Article 10 cases were filed. 26 Investigations remained pending, and 24 outcomes were unknown during the 3rd quarter.

Additionally, 82 Clients received SCR representation and 22 cases, thus far, have been amended and sealed

2. Build & support the interdisciplinary team.

- Attorney-led interdisciplinary teams are crucial to client success.
- Social workers and mentor parents receive support through clinical supervision.
- Full team stays connected through regular staffings on cases.

3. Remain based in community.

- Physical presence in the community
- Know Your Rights presentations (shelters, jails, schools, hospitals)
- Strategic partnerships with other service providers (e.g., probation office, county ob/gyn clinic)
- Familiarity with local resources and service providers in order to make quick & accurate referrals

4. Keep the client at the center.

- Honor client self-determination in identifying case goals and outcomes
- Work with the client around both immediate investigation and longer-term, underlying challenges that could lead to investigations again in the future

5. Stay rooted in a vision of a different way.
